### **NEW JERSEY IS OPEN FOR CLEANTECH INVESTMENT**

*Record Number of New Jersey Businesses, Municipalities and Schools Nominated  
For 2008 New Jersey Clean Energy Leadership Awards*

(NEWARK, NJ) – The New Jersey Board of Public Utilities (BPU) today announced it received a record 50 nominations for the *2008 Clean Energy Leadership Awards*. There were 23 nominations in 2007. This is the fourth consecutive year the awards are being presented.

The nominees fall within eight award categories including: *Business Leader of the Year; Small Business Leader of the Year, Cleantech Company, Clean Energy Educator, Clean Energy Market Innovator, Clean Energy Municipality, Clean Power Purchaser and Clean Energy Project of the Year.*

“The number of nominations reflects the tremendous growth of the clean energy sector and demonstrates that New Jersey is without a doubt open for clean tech business,” said BPU President Jeanne M. Fox.

Businesses, municipalities and schools across the state are increasingly investing in clean energy solutions to help reduce energy usage, improve their bottom line and help protect the climate. The New Jersey Clean Energy Leadership Awards will recognize some of these entities for outstanding projects that use energy efficient and renewable energy technologies to help reduce greenhouse gases and deliver savings.

“In today’s business climate, it is no longer a question of whether you can afford to invest in clean technology. The question is can you afford not to,” added President Fox. “Clearly, the outstanding projects recognized by the Clean Energy Leadership Awards demonstrate that their developers ‘get it.’ Investing in a cleantech economy is not just good for the environment, it also is good for business.”

This year’s nominees reflect a broad array of clean energy projects and applications, ranging from energy-efficient, affordable housing and solar installation ventures to large scale, demand-side management projects – each of which helps reduce energy, saves money and protects the environment.
